## HISTORY & SOCIAL CHANGE

### WOMEN'S HISTORY

#### Women and Social Movements in the US, Sexuality and Bodies

**NEW!** The Spring issue, "Sexualities and Bodies," features a very rich document project by Jamie Wagman entitled "Transgender in the Heartland: Transitioning and Seeking Community in Middle America." This project consists of oral history interviews, including both audio files and transcripts, of twenty transgender women and men who grew up or currently live in the Midwest, many in small towns and rural areas. Also included is a roundtable, "Women, Gender, and Sexuality in the Archives," featuring contributions from Morna Gerrard, archivist for Women and Gender Collections at Georgia State University Library; Jeff Snapp, formerly of the National Endowment for the Humanities (NEH) Project Archivist at ONE Archive; and Liana Zhou, Director of the Kinsey Institute Library and Special Collection.

#### Women and Social Movements in the US, Women's Citizenship and State Power

**COMING IN OCTOBER 2020!** The Fall 2020 edition focuses on questions of women's citizenship and state power in the mid-twentieth century U.S. It features two document projects that, in the broadest sense, show how different American constituencies grappled with the growing power of the federal government and the struggle to define the meaning of national citizenship in ways that accorded with their own understanding of their place within the national polity. The first document project, by Mary Klann, focuses on Native American women's opposition to termination — the policy approach pursued by the federal government beginning in the 1940s that, in the name of assimilation, aimed to "terminate" the government's special relationship with Native American tribes. A second document project, by David Dawson and Rebecca Jo Plant, explores congressional debates during World War II over whether to draft women for civilian work, as Britain did, in order to maximize its human resources.

#### History Vault: Southern Women and their Families in the 19th and 20th Centuries

**COMING IN NOVEMBER 2020!** Seen through women's eyes, studies of 19th century southern social history takes on new dimensions. Women's letters dwell heavily on illness, pregnancy, and childbirth. From them we can learn what it was like to live in a society in which very few diseases are well understood, in which death was common among all age groups, and infant mortality was an accepted fact of life. The years of the Civil War are particularly well documented since many women were convinced that they were living through momentous historical events of which they should make a record. After the war ended and the "new South" began to take shape, other women wrote memoirs for their children and grandchildren hoping to preserve forever their memories or to record the sacrifices and heroism they had witnessed.

### MEN'S HISTORY

#### GQ Archive

**NEW!** The backfile of *GQ* magazine, from its launch in 1931 to the present. One of the longest-running, most influential men's magazines, *GQ* (previously *Apparel Arts*) launched as a fashion trade title but subsequently expanded its coverage to encompass broader men's interest subjects. The digital archive will make available a wealth of editorial content and photography, shedding light on the 20th/21st-century history of fashion, popular culture, masculinity, and society.

### Men's Magazine Archive

**COMING IN SEPTEMBER 2020!** This pioneering collection of men's magazine backfiles features some of the earliest and most influential publications of this type — *National Police Gazette* (1845-1977) and *Argosy* (1882-1978) — among other leading titles covering general interests (*Esquire* [UK edition]), fashion (*M*), and sports (*All Sports Illustrated Weekly*, *Sports Budget*). As well as meeting the requirement for dedicated men's studies primary sources among researchers in this area, it discloses broader trends in history, society, and popular culture, while offering valuable additional perspectives for women's studies research.

### US HISTORY

#### History Vault: Japanese American Incarceration: Records of the War Relocation Authority

**NEW!** Following the Japanese attack on Pearl Harbor and the U.S. entry into World War II in December 1941, the Roosevelt administration decided that for reasons of "military necessity," the government would evacuate all persons of Japanese heritage from the West Coast states. The Records of the War Relocation Authority document the day-to-day running of the 10 relocation camps from 1942-1946. The collection is organized by relocation center. Records include reports and correspondence on issues such as security, education, health, vocational training, agriculture, food, and family welfare.

#### History Vault: Temperance and Prohibition Movement

**COMING IN DECEMBER 2020!** The temperance and prohibition movement constituted an important element in American political life and its significance as a vital force in American social history during the late 19th and early 20th centuries. This module contains records and publications of the principal organizations which sought to reduce and ultimately to eliminate the manufacture and sale of alcoholic beverages in the United States. The two largest organizational collections in the module are the Anti-Saloon League of America (A.S.L.A.) and the records of the Woman's Christian Temperance Union (W.C.T.U.) The papers of individuals prominent in the movement are included as well.

### BLACK HISTORY

#### History Vault: Slavery, the Slave Trade and Law and Order in the 19th Century America

**NEW!** This module documents the international and domestic traffic in slaves in Britain's New World colonies and the United States, providing important primary source material on the business aspect of the slave trade. In addition to records on the slave trade, this module also includes letters received by the Attorney General on law and order in 19th century America. These letters cover the slave trade, general slavery matters including runaway slaves and rights of slaves, and other legal issues.

### EARLY MODERN HISTORY

#### Early European Books 17—Law and Politics (BnF and Arsenal)

**NEW!** This collection will focus on Law and Politics, with discourses on government and political theory. The materials will include ordinances, edicts, proclamations and political tracts on topics of jurisprudence.

## MILITARY & DIPLOMATIC HISTORY

### History Vault: CIA Cold War Research Reports and Records on Communism in China and Eastern Europe

**COMING IN SEPTEMBER 2020!** This module consists of two major series of records: CIA Research Reports from 1946-1976 and records collected by Raymond Murphy on Communism in China and Eastern Europe from 1917-1958. Beginning in 1946 with reports of the CIA's predecessor, the Central Intelligence Group, CIA Research Reports reproduces over 1,500 reports on eight areas: Middle East; Soviet Union; Vietnam and Southeast Asia; China; Japan, Korea, and Asian security; Europe; Africa; and Latin America. This series deals with international questions and biographical reports, offering profiles of relatively unknown leaders.

The Murphy Collection provides information on war recovery efforts, international aid, and the formation of countries and substantial information on the Chinese Communist Party.

## CULTURAL HISTORY

### Health and Fitness Magazine Archive

**COMING IN AUGUST 2020!** With publications aimed at a male readership (e.g. *Flex*, *Men's Health*) and women's titles (e.g. *Women's Health*, *Women's Health Activist*), this collection supports research in topics such as the history of sex roles, body image, fitness/exercise, public health, food/nutrition, and medicine. The backfile of *Prevention* (from 1950) offers over six decades of content reflecting contemporary developments in these areas.

### PROQUEST HISTORICAL NEWSPAPERS

With more than 65 premier stand-alone historical titles dating back to the 1700s and more than 75 million digitized pages, ProQuest Historical Newspapers is the definitive newspaper archive empowering researchers to travel back centuries and become eyewitnesses to history. ### ProQuest Historical Newspapers: Specialty Collections Michigan Chronicle (1936 – 2010)

**NEW!** A weekly black newspaper founded in 1936 by the publisher of the *Chicago Defender*, The *Michigan Chronicle* played a significant role in the 20th century civil rights. The *Chronicle's* support of organized labor and the democratic party were viewed as radical in the newspaper's early years. The newspaper played a critical part in breaking down the barriers of racism, bigotry and discrimination in Detroit and throughout the state. This newspaper has been digitized at the article-level to be consistent with other Black Historical Newspaper titles, allowing for cross-searching and bundling.

### Leftist Newspapers and Periodicals

**NEW!** Leftist Newspapers and periodicals are a collection of 140+ newspapers and periodicals supporting the ideology of socialism, communism, and Marxism. The collection titles were published throughout the English-speaking world from 1900-2015. Issues covered include workers' rights, organized labor, labor strikes, Nazi atrocities, McCarthyism's rise after WWII, Civil Rights, and modern-day class struggles which encourage renewed interest in alternative social organizations.

#### Regulatory Insight: Historic Rules & Guidance

**COMING IN DECEMBER 2020!** Regulatory Insight Historic Rules & Guidance is a collection of historic documents, most issued prior to 1936. Historic guidance documents include manuals, circulars, orders and more, sourced from Executive Branch Documents. Historic rules and regulations are organized by Agency and compiled into regulatory histories associated with Public Laws or Executive Orders as appropriate by ProQuest researchers. Save time!

#### Executive Branch Documents – Collection 6

**COMING IN Q4 2020!** The sixth Executive Branch content module for ProQuest Congressional extends the date range for existing content (1789–1948) to include approximately 60,000 records from 1949–1952. Containing documents produced by Federal government departments, agencies, and commissions, Executive Branch Documents 6 touches upon all aspects of U.S. social, political, and economic life, as well as major events in U.S. history, and provide points of comparison between the U.S., and selected foreign countries. This collection covers the mid-20th century timeframe, including demobilization of the armed forces, implementation of the Marshall Plan and the revision of the Mutual Security Act to create the Department of Defense. It also covers the Truman Doctrine, Berlin airlift, formation of NATO, the Korean War, activities of the Atomic Energy Commission and more! Suitable for researchers in many academic disciplines including political science, history, law, business, social sciences, agriculture, engineering, military history, and education.

### POLICY

#### Trends & Policy: US Immigration

**COMING IN Q4 2020!** Immigration is the inaugural module for ProQuest's new Trends and Policy product line. This collection connects policies implemented by the U.S. government with the data-driven results and trends of those policies and provides context with analytical reports and news articles. ## DNSA: Donald Rumsfeld Files [Working Title]

**COMING IN DECEMBER 2020!** The product of a National Security Archive lawsuit, this collection will eventually publish every "snowflake" memo the Secretary of Defense circulated during his tenure—over 65,000 in all. Covering some of the most significant and sensitive issues from a tumultuous period, these memos offer an extraordinary schematic of U.S. defense and national security policy in the months prior to and after the 9/11 terrorist attacks, as well as insights into the (often petty) priorities of the George W. Bush administration and one of its most memorable characters.



### GLOBAL ISSUES

#### Mass Incarceration and Prison Studies

**NEW!** Global Mass Incarceration and Prison Studies Online is a database curated by an international board of advisors and part of the Global Issues Library. Organized around a selection of key historical and contemporary events and mixing a case and thematic approach, this resource will look at the history of incarceration in the United States, Russia, the United Kingdom, Australia, Canada and others. The main themes and events related to mass incarceration and the history of prisons are easily explored by providing multiple perspectives and points of entries: court cases; prison experience: first-hand accounts; law and government documents; rehabilitation; training materials; policing and law; prison and identity and theory.
